Please read carefully and save these instructions, as you may need them at a later date.

CAUTION

Turn off the main power at the circuit breaker before installing the fixture in order to prevent possible shock.

All electrical connections must be in accordance with local and National Electrical Code (N.E.C.) standards. If you are unfamiliar with proper electrical wiring connections, obtain the services of a qualified electrician.

GENERAL

Remove all parts and hardware from the box and the mounting package and make sure that none are missing by referencing the illustrations provided.


ASSEMBLY AND INSTALLATION

- 1. Pull the SUPPLY WIRES (4 & 6) and the SUPPLY GROUND WIRE (8) out from the OUTLET BOX (1) (not included) and attach the MOUNTING STRAP (2) assembly to the OUTLET BOX (1) using the slotted holes of the MOUNTING STRAP (2) and the OUTLET BOX SCREWS and WASHERS (3), [See Fig. 1]
- 2. Remove THREADED RING (14) from SCREW COLLAR LOOP (12) on MOUNTING STRAP (2). Place the CANOPY (11) over the OUTLET BOX (1) and adjust the SCREW COLLAR LOOP (12) and THREADED ROD (20) until the midpoint of the outside threads on the SCREW COLLAR LOOP (12) is centered (aligned) with the surface of the CANOPY (11). Remove the CANOPY (11) and tighten both HEX NUTS (21) down on the MOUNTING STRAP (2) and the SCREW COLLAR LOOP (12), [See Fig. 1]
- 3. Attach one OPEN CHAIN LINK (18) to each end of the CHAIN (13). Then attach one end of the CHAIN (13) to the FIXTURE LOOP (16). Slide the THREADED RING (14) and the CANOPY (11) (in that order) onto the CHAIN (13) and attach the other end of the CHAIN (13) to the SCREW COLLAR LOOP (12). Close the OPEN CHAIN LINKS (18). [See Fig. 1 & 2]
- 4. Unravel the FIXTURE LEAD WIRES (5 & 9) and FIXTURE GROUND WIRE (7) and thread them through every other link of the CHAIN (13) starting with the chain link attached to the FIXTURE LOOP (16). Feed the FIXTURE LEAD WIRES (5 & 9) and FIXTURE GROUND WIRE (7) through the SCREW COLLAR LOOP (12) and THREADED ROD (20), Pull the FIXTURE LEAD WIRES (5 & 9) and the FIXTURE GROUND WIRE (7) upward to remove any excess slack. [See Fig. 1]
- 5. Attach the power supply wires to the fixture lead wires by connecting the BLACK SUPPLY WIRE (4) to the SMOOTH FIXTURE LEAD WIRE (5) and the WHITE SUPPLY WIRE (6) to the RIBBED FIXTURE LEAD WIRE (9). Loop the SUPPLY GROUND WIRE (8) around the GROUND SCREW (19) on the MOUNTING STRAP (2). [Note: Be sure to provide an extra 3in. length of the SUPPLY GROUND WIRE (8) for connection to the FIXTURE GROUND WIRE (7). Tighten the GROUND SCREW (19). Connect the remaining SUPPLY GROUND WIRE (8) to the FIXTURE GROUND WIRE (7). Use a WIRE CONNECTOR (10) for all wire connections. Push wiring and connections inside the OUTLET BOX (1). [See Fig. 1]

ASSEMBLY & INSTALLATION (Continued)

- 7. Slide the CANOPY (11) and the THREADED RING (14) up the CHAIN (13). Place the CANOPY (11) over the OUTLET BOX (1) and secure it by screwing the THREADED RING (14) onto the SCREW COLLAR LOOP (12). [See Fig. 1]
- 8. Attach GLASS SHADE (17) to FIXTURE (15) with the SOCKET RING (22), [See Fig. 2]
- 9. Install bulb (not included), MAXIMUM 100W.

Craftmade Lighting Limited Warranty

Craftmade warrants all its Products to be free from defects in material and workmanship, subject to certain conditions and exclusions, for period of one year from the date the Product was shipped to the original end use purchaser. Craftmade will warranty its product only if it is sold through an authorized Craftmade dealer. Craftmade will, at its discretion, repair, replace or make appropriate adjustment where inspection discloses any defects occurring in normal usage within the applicable time period above, subject to the following conditions and exclusions.

The following costs, expenses and damages are not covered by the provisions of this limited warranty: (1.) labor costs including, but not limited to, costs associated with the removal and reinstallation of Product; (2.) shipping and freight expenses required to return Product to Craftmade.

All warranties only apply to the original end use purchaser and original installation of Products. **This warranty is not transferable**. The provisions of this warranty to not apply to products that are used in commercial applications; used for purposes for which they are not designed or intended; which have been subjected to alteration, accidental damage, abuse, misuse, negligence or accident; which have been improperly stored, installed, maintained or operated; which have been used in violation of written instructions provided by Craftmade; which have been subjected to improper temperature, humidity or other environmental conditions; or which, based on examination by Craftmade, do not disclose to the satisfaction of Craftmade non-conformance to the warranty. Additionally, this warranty DOES NOT COVER scratches, abrasions, or deterioration due to the use of paints, solvents, chemicals or abrasive cleaning techniques.

The above warranties also do not apply if:

- The original bill of sale, delivery date, or product number cannot be verified.
- The parts claimed to be defective are not returned for inspection if so requested by Craftmade.
- The product is not in the possession of the original end use purchaser at the time warranty claim is made.

Warranty Exclusions:

- Craftmade uses the best weather resistant finishes, nevertheless finishes for fixtures installed outdoors are subject to change due to prolonged exposure to sunlight, pollutants and other environmental conditions. Any claim for fading, discoloration or "patina" of a finish on an outdoor fixture is not applicable to the above warranty. See the "Finish Care & Cleaning" instructions below for proper care and maintenance of your fixture.
- The environment within ten miles of a sea coast can be extremely corrosive. Even with the appropriate maintenance, products installed in this environment will typically deteriorate more than products installed in a less severe environment. Some corrosion and/or deterioration is considered "normal wear" in this environment. Any claim for finish failures or for corrosion of other components due to coastal environment conditions is not applicable to the above warranty.
- We cannot warranty our Direct Burial Poles due to environmental issues such as moisture, soil acidity and other corrosive soil and air conditions.

Craftmade strives to assure that glass and metal finishes shown in our catalogs match the actual product, but chemical finish variations and hand applied finishes can result in differences between the actual product and printed images.

Craftmade does not authorize any person to create for it any obligation or liability in connection with its Products. The maximum liability is limited to the original purchase price of the product. No action arising out of any claimed breach of this warranty by Craftmade may be brought by the Original User more than one (1) year after the cause of action has arisen.

IMPLIED WARRANTIES INCLUDING THAT OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE ARE EXPRESSLY LIMITED TO THE DURATION OF THIS WARRANTY. CRAFTMADE AND/OR SELLER DISCLAIMS ANY LIABILITY FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES.

Particular care should be taken to avoid abrasive materials and strong cleaning agents as they will quickly destroy the protective coatings and subject the finish to oxidation and discoloration.
